Morning Care	<ul> <li>\$35.00 per month for student that uses the program between 7:30 am - 8:10 am drop off, regardless of the number of days attended</li> </ul>	Due monthly on the 25th of the month by PAD agreement (auto withdrawal)
After School Care (Grade 1-6)	• \$310.00 per month for Grade 1-6 students that attend After School Care, 3:15 - 5:30 pm on school days	Due monthly on the first of the month by PAD agreement (auto withdrawal)
After School Program (Grade 7-9)	• \$190.00 per month for Grade 7-9 students that attend the After School Program, 3:15-5:30 pm on school days. Part-time rate \$10/day for a maximum of 10 days, after 10 days \$190 per month would apply.	Due monthly on the first of the month by PAD agreement (auto withdrawal).

## School fees will be posted in the parent portal.

- After School care fees/overtime fees will be posted on the parent portal monthly.
- Morning Care fees will be posted each month by the 25th of the month. For example, September fees will be posted by September 25th.
- Pizza lunch and other fees (extra agenda, t-shirt, lost library books, club fees, etc.) will be posted on the parent portal as applicable.

- PAD agreements (auto withdrawal) are mandatory for monthly user-pay programs After School Programs and Morning Care.
- Credit card payment by phone to Ms. Amin at 780.468.2598 ext 247 (please note credit card merchant fees are an additional cost to the school; therefore, PAD agreements and E-transfers are preferred).
- Parents who are eligible (live more than 1.0km from the school) may have their Transportation Grant applied to their instructional, lunch supervision and junior high option fees. Any credit remaining at the end of the year will be sent to parents via cheque by August 31, 2025.
- We are not taking cash payments at this time.
